h. In completing this research project, will you be able to use a wide variety of appropriate sources?

2. Bibliography: For each of the 5 topics, you must find 3 credible articles and complete an MLA-style or APA-style bibliography for each topic. One of your bibliographies must have at least 1 annotated bibliography entry, (3 entries total per topic). (See example from Cornell University below).

(So to sum up: 5 topics. For each topic you will have 3 bibliographies, for a total of 15 Bibliographies. Also, 5 of the total bibliographies must be annotated bibliographies. So once you pick a topic, for example: Online Learning, that topic will have a list of three bibliographies from credible sources, and JUST one of those bibliographies will be an annotated bibliography. For a total of 2 bibliographies and one annotated bibliography.)

The authors, researchers at the Rand Corporation and Brown University, use data from the National Longitudinal Surveys of Young Women and Young Men to test their hypothesis that nonfamily living by young adults alters their attitudes, values, plans, and expectations, moving them away from their belief in traditional sex roles. They find their hypothesis strongly supported in young females, while the effects were fewer in studies of young males. Increasing the time away from parents before marrying increased individualism, self-sufficiency, and changes in attitudes about families. In contrast, an earlier study by Williams cited below shows no significant gender differences in sex role attitudes as a result of nonfamily living.
