5. **ACTION ITEMS RECOMMENDED BY THE SUPERINTENDENT OF SCHOOLS**
 - A. **BE IT RESOLVED** that the Board of Education approves the resignations, terminations, leaves of absence, position abolitions, employment appointments, tenure appointments, and salary changes in accordance with applicable provisions of Education Law and Civil Service Law, as cited in the **Personnel** Changes attachment.
 - B. **BE IT RESOLVED** that the Board of Education accept the donation of \$10,225 from the FTK Foundation which will be used to fund the High School and Middle School Musicals. The codes to be increased are 2850-133-08-0000 in the amount of \$3,089 and 2850-133-09-0000 in the amount of \$7,136.
 - C. **BE IT RESOLVED** that the Board of Education accept the donation of \$2,500 from

Dr. Chirakkal Krishnan, a former Science teacher. This donation was presented by the For The Kids Foundation on behalf of Dr. Krishnan. These funds will be used to purchase two MACBOOK Pro Computers and a Deskjet Printer/Scanner/FAX/Copy machine for the Medical Academy at the High School. The code to be increased 2630-220-00-6000.

- D. **BE IT RESOLVED** that the Board of Education accept the donation of \$7,500 from Suffolk Transportation Service, Inc. to the East Islip School District to fund the Middle School Sports Program. The code to be increased 2855-133-00-0000.
- E. **BE IT RESOLVED** that the Board of Education approve the membership with R.E.F.I.T., Reform Educational Financing Inequities Today, for the 2013-14 school year. The annual membership dues are \$600.
